Information We Collect Through the Site

Online Donations and Other Transactions

If you donate or make another transaction online, you may provide information such as name, email, billing address, and the amount donated. Card/bank details are transmitted to our processors (Stripe/PayPal) and are not stored on our servers.

Program Registration

When you apply to adopt, foster, or volunteer, you may provide personal and household details, housing/landlord info, pet history, references, and lifestyle information.

Sign-Ups and Correspondence

If you sign up for emails, newsletters, events, or contact us, we may collect your name, email, mailing address, phone number, and message content.

Contests and Promotions

When you participate in promotions we sponsor, we may collect your contact information and other details needed to administer the promotion (subject to the official rules).

Interactive Forums

If our site offers comments or other interactive features, information you post may be viewable by others who access those areas.

Social Networking & Social Sign-In

If you interact with us on social platforms or use a social sign-in, we may receive information from those platforms, consistent with their policies and your settings.

Usage and Location Data

We may collect usage data (pages viewed, links clicked, referring/exit URLs, IP address or device identifier) and approximate location (e.g., via IP address).

Online Information-Gathering Tools

We use cookies, pixels, web beacons, and similar tools for site functionality and analytics/measurement. You can manage cookies in your browser or via our cookie

banner when available.

Third-Party Integrated Services

We may integrate third-party content and tools (e.g., analytics, embedded widgets), which may allow those providers to collect information per their own policies.

Online Inquiries

When you submit an inquiry or otherwise correspond with us, we collect the information you provide so we can respond.

How We Use Information Collected Through the Site

- Operate rescue programs (review applications, match animals, schedule meet-and-greets, coordinate transports, provide post-adoption support).
- Process donations, send acknowledgments and tax receipts, and steward donors.
- Manage adoption listings and interest via Petfinder and communicate with you via HubSpot.
- Send newsletters, updates, impact reports, and opportunities to support; honor unsubscribe requests.
- Comply with legal obligations, prevent fraud, and protect people and animals.
- Improve our website and services (including analytics and measurement).

Donor Privacy

We do not sell, rent, or trade donor personal information or our mailing lists. We use donor information only to process gifts, send acknowledgments/tax receipts, and share

impact updates and opportunities to support. Donors may give anonymously and may opt out of public recognition and non-transactional communications at any time by emailing info@littlebeansshoperescue.org.

When We Disclose Information to Third Parties

- **Within our organization:** to team members and volunteers with a need to know, under confidentiality obligations.
- **Service providers:** hosting/IT, forms/cloud storage, analytics, email & CRM (HubSpot), adoption platforms (Petfinder), payment processors (Stripe/PayPal)—limited to what's needed to perform services.
- **Partners:** veterinary clinics, transport partners, and co-host rescues involved in approved placements/events.
- **Aggregated/de-identified data:** we may share summaries that do not identify you.
- **Corporate transactions:** if we undergo a merger or asset transfer, information may be transferred as permitted by law.
- **Legal & safety:** to comply with law or protect rights, property, safety, and to prevent fraud or abuse.

We do not sell personal information.

Security Measures

We employ administrative, technical, and physical safeguards intended to protect information collected through our site. However, no method of transmission or storage is 100% secure.

How to Correct or Update Your Information

You may request access, correction, or deletion by emailing info@littlebeanshoperescue.org. We will verify your request and respond within **45 days** (we may extend once by an additional 45 days where reasonably necessary and will notify you).

You may also unsubscribe from marketing emails via the “unsubscribe” link in our messages.

How We Respond to Do Not Track

At this time, our site does not respond to Do Not Track (DNT) signals. You can manage cookies in your browser settings or via our cookie banner when available.

Transfer of Data from Outside the United States

If you access our site from outside the U.S., your information may be transferred to and processed in the U.S. and other countries by our service providers.

Children

Our site is not designed to appeal to persons under **18**. We do not knowingly collect personal information from children under **18** without verifiable parental or guardian consent.

Privacy Policies of Linked Websites

Your California Privacy Rights (Shine the Light)

California residents with whom we have an established relationship may request information regarding our disclosure of certain categories of personal information to third parties for their direct marketing purposes, if any, during the prior calendar year. Other State-Law Notices (including Florida)

Florida: The Florida Digital Bill of Rights primarily regulates certain large for-profit businesses and generally does not cover nonprofits. Separately, Florida's breach-notification law (FIPA) requires notice to affected individuals and, for breaches affecting **500+** Florida residents, notice to the Florida Attorney General—generally within **30 days** of determining a breach, subject to lawful delays.

Other states: Where applicable law grants additional rights, we honor them. For example, the Colorado Privacy Act applies to nonprofits and Oregon's Consumer Privacy Act applies to nonprofits (effective July 1, 2025). Residents may have rights to access, correct, delete, receive a portable copy,

and opt out of certain processing. To exercise rights, email info@littlebeanshoperescue.org. We do not “sell” or “share” personal information as defined by applicable law. If you disagree with our response, reply “Appeal.”

Governing Law

By choosing to visit our site, you agree that any dispute over privacy or the terms in this policy will be governed by the laws of the State of **Florida**, without regard to its conflict-of-laws principles, and subject to any dispute-resolution terms applicable to our site.
